Networking and Critical Thinking Training

Introduction about SCVG

Social Care Volunteer Group (SCVG) is a principle-based, non-profit, non-religious, non-partisan and non-ethnic civil society organization based in Magway, Myanmar. SCVG served several thousands of youth and children through its interventions: HIV prevention, youth empowerment, emergency response in disaster, legal aid, child rights governance, child protection, gender-sensitivity health services, CSO/ CBO strengthening and youth capacity building activities.

Background of Training

SCVG is implementing a project titled "Promoting the Rule of Law in Anti-Trafficking in Persons" funded by USAID Promoting the Rule of Law in Myanmar (PRLM) in Magway, Yenangyaung and Chauk Townships in Magway Region.

One of the capacity building activities of the project is to provide a three-day training on Networking and Critical Thinking for 20 community-based para-legal volunteers from Magway, Yenangyaung and Chauk Township and SCVG staff members. The training location will be determined based on the COVID-19 situation.

Objectives of Training

At the end of the training, SCVG staff members and community-based para-legal volunteers shall be improved in skills and concepts of networking and critical thinking which can be applied for future activities to achieve the project.

Scope of Role

Title: Trainer for Networking and Critical Thinking Training

Report to: Programme Manager (Social Care Volunteer Group – SCVG)

The trainer shall be responsible to conduct the Networking and Critical Thinking Training for community based para-legal volunteers and SCVG staff members under the overall authority of Programme Manager. The trainer will perform the following tasks;

- Develop a training curriculum for the Networking and Critical Thinking Training including pretest and posttest and training evaluation forms (subject to donor review)
- Deliver a **three-day training** on Networking and Critical Thinking
- Submit a written training report including the pretest and posttest result.

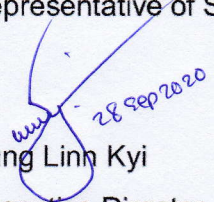
- Academic qualification in the field of community development, humanitarian or other relevant fields.
